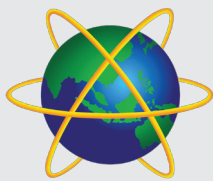

- If a student chooses to discontinue his/her studies at **Asia Pacific Smart School**, a notice of withdrawal should be given **6 months (1 semester)** prior to the student's last day of school.
- Valid reasons should be included in the notice of withdrawal and parents/guardians are required to attend a session of 'exit interview' with the School.
- Outstanding school fees must be settled in full before the student's last day at school.
- All withdrawals are subject to administrative charges of RM100 per student.
- The Deposits will ONLY be refunded if all the above (1-4) are complied accordingly.
- For any withdrawal before the commencement of the School term/course, fees paid will be refunded. However, if the student withdraws after the term/course commences, fees paid will not be refunded.
